E-Tenders on ML&C website, in favor of Cantonment Executive Officer, Malir Cantonment are invited from contractors registered with Pakistan Engineering Council in relevant category possessing valid up-to date renewal of their firms from PEC, for execution of following M&R works for the financial year 2021-2022:-

TERMS AND CONDITIONS

1. Tender documents, instruction and specification can be viewed / downloaded from e-tender portal at <https://etender.mlc.gov.pk>
2. The tenderer shall submit 2% bid security of the estimated cost in the shape of call deposit in the favor of Cantonment Executive Office Malir Cantonment Board and upload / attach its valid soft copy alongwith bid challan with the electronic bid before closing date & time.
3. The tenderer is bound to electronically submit verified and genuine documents as well as call deposit, if in case the documents are found altered / fake / bogus, the Cantonment Board is at liberty to initiate criminal proceedings by lodging FIR on the basis of forgery / fraud against the tenderer and the firm shall be black- listed following due course of action.
4. The tenders can only be submitted in electronic format through e-tender portal from date of publication in newspaper and portal, the deadline for submission of tender is **21/3/2022** at **1200hrs** tenders would be opened on the same day at **1400hrs** in the presence of contractor or their authorized representatives.
5. "Single stage one envelope E-tendering system will be adopted / followed" as envisaged in PPRA rules.

6. No manual tender shall be entertained.
7. Any information regarding the e-tender can be obtained from the office of the Cantonment Board Malir during office hours. Furthermore, the contractor user manual regarding bidding has been uploaded in English and Urdu language on the e-tender portal, which can be accessed and downloaded.
8. The validity of Tender rates shall be minimum upto **90** days.
9. The Cantonment Executive Officer reserves the right of demanding the analysis of the quoted rates from the concerned tenderer to check their responsibility and workability.
10. In case the lowest quoted rates for above works are lesser than the 20% above the MES Schedule of rates 2014, the contractors shall be bound to furnish the performance guarantee equivalent to 10% of the estimated cost of respective work in shape of call deposit (CDR) in favor of Cantonment Executive Office Malir Cantonment Board issued by any scheduled bank of Pakistan. The pledged performance guarantee shall be released / returned after successful completion of the work.
The performance guarantee shall be submitted within 07 days of issuance of LoA. If the contractor fails to provide the same within stipulated time, the earnest money of the contractor shall be forfeited and the work will be awarded to 2nd lowest firm on similar conditions.
11. The quantum of work may increase / decrease following the instructions contained in PPRA Rules and lowest tenderer shall be bound to execute the work on similar rates / terms & conditions.
12. Bidding documents will be issued by Cantt Board Malir keeping in view the relevant PEC's Category, criteria and job specialization.
13. Rates should be quoted on the basis of MES Schedule of Rates **2014** (amended upto date) for schedule items and market rates for non-schedule items.
14. Conditional / incomplete tenders / quotation wherein necessary details are missing will not be accepted.
15. Cantonment Board will not be responsible to provide equipment material or plants & store etc.
16. The contractor will have to bear the expenditure of material test and field test from recognized laboratory.

17. All the applicable Government taxes will be paid by the firm/ contractors.
18. No request for escalation in rates will be entertained at any stage.
19. The M&R rates quoted for above works shall remain valid till the calling and subsequent approval of rates for the next financial year 2022-2023.
20. Successful tenderer shall have to execute an agreement (at their own cost) on non-judicial stamp paper of appropriate value for faithful execution of the contract.
21. The Cantonment Board / Executive Officer reserves the right to reject all tenders as per PPRA's Rule No. **33(1)** due to any reason thereof.
