PLAN OF THE SITES

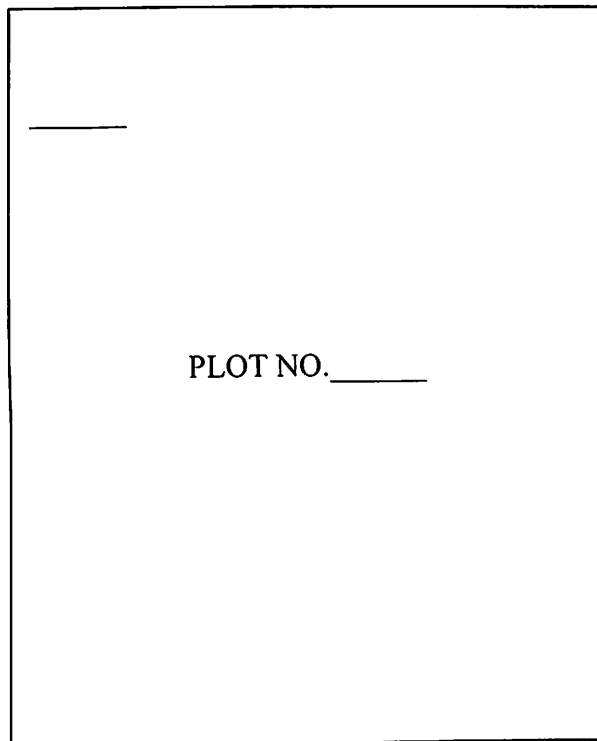
