In case the bid is less than 10% of the estimated amount, the lowest bidder shall have to deposit standing security (refundable after successful completion of the work) i.e. a reasonable amount decided by the Cantonment Executive Officer in the shape of Call deposit within 07 days. In case of failure the already deposited 2% earnest money shall be forfeited and bid will be cancelled.
